Sub: Selection to the post of Ticket Examiner in Pay Matrix Level 3
Against 16 2/3% LDCE Quota in Commercial Department.

I. The under mentioned employee who has been empanelled for promotion to the post of Ticket Examiner in pb 5200-20200 with GP Rs.1900/- (Pre-Revised) against 16 2/3% LDCE Quota and who has successfully completed the initial training course at ZRTI/TPJ from 15-10-2018 to 16-11-2018, is promoted as Ticket Examiner in level 3 of Pay Matrix of VII PC and posted to the station indicated below with immediate effect.


II) पदोन्नत कर्मचारी पदोन्नत ग्रेड में 12 महीने की अवधि के लिए परीक्षा पर होंगे। परीक्षा अवधि की समाप्ति पर यदि नियुक्ता प्राधिकारी को लगता है कि पदोन्नति पर परीक्षा अवधि के एक वर्ष के दौरान रेलवे कर्मचारी का कार्य निष्पादन संतोषजनक नहीं पाया गया हो या कुछ और समय उनके काम के निरीक्षण की आवश्यकता हो तो उन्हें पदोन्नत किए गए ग्रेड या पद को वापस प्रत्यावर्तित कर सकते हैं या भारे स्थानि। के पैरा 113 में अनुबंधित अनुसार जो भी मामला हो परीक्षा की अवधि बढ़ाई जा सकती है।

The promoted employees will be on probation for a period of 12 months in the promoted grade. At the end of the probation period, if the appointing Authority considers that the work of the Railway Servant during the one year probation period on promotion has not been satisfactory, or the same is needed to be watched for some more time, he may revert back to the post or grade from which he was promoted or extend the period of probation as the case may be, as stipulated in Para 113 of IREM- I.

III) पदोन्नति इस समग्र विचार पर आदेशित है कि वे कोई दण्ड न भुगत रहे हो जो उन्हें पदोन्नति/स्थानापन्न से रोकें। तथापि वे कोई दण्ड भुगत रहे हैं तो दण्ड से मुक्त होने तक ऐसा माना जाएगा कि वे वर्तमान इयूटी ही निभा रहे हैं।

The promotion is ordered with the overall consideration that he is not undergoing any punishment, debarring him from promotion/officiating arrangement. However if he is undergoing any punishment he will be deemed to allowed carry out the current duties till he become free from punishment.

IV) पदोन्नति आदेश की तारीख से 15 दिन के भीतर पदोन्नति प्रभावी होगी। ऊपर निर्दिष्ट अवधि के भीतर कर्मचारी की कार्यमुक्ति में इस कारण से विलंब नहीं होना चाहिए कि कर्मचारी ने अपील की है जो निपटान के लिए लंबित है। निर्दिष्ट अवधि के भीतर पदोन्नत होने के लिए कर्मचारी इच्छुक न हो तो उसे पदोन्नति से इनकार माना जाएगा और उन्हें आदेश जारी करने की तारीख से एक वर्ष की अवधि के लिए पदोन्नति से विवर्जित किया जाएगा।

The promotion should be given effect to within 15 days from the date of receipt of orders. If the employee is not willing to be promoted within the specified period, the same will be treated as refusal of promotion and he/she will be debarred from promotion for One year from the date of issue of the order.

V) उपर्युक्त पदोन्नति उच्चतर दायित्व संभालने की तारीख से प्रभावी होगी ।

The above promotion will take effect only from the date he assuming higher responsibility.

VI) The above promotion order is provisional and subject to outcome of various cases pending in Courts, Tribunals etc.

VII) The promotions are provisional and subject to outcome of the pending contempt petition Civil No. 314/2016 and SLP Civil No.4813/2012.

कर्मचारी सभी तरह के स्थानांतरण सुविधाओं के लिए पात्र होंगे। The employee is eligible for all transfer privileges.

Railway quarters occupied if any at their present station, should be vacated immediately on their relief unless they seek permission for retention of the same from this office. Failure to comply will be treated as un-authorised occupation and damage rent will be recovered from their salary.

The employees may carry out their promotion/transfer within 15 days from the date of receipt of this order. If not, the Supervisory official concerned will be responsible for the same.


Any excess payment found to have been made in regard to this Order is required to be refunded, when detected later by Railway.
