He is free from DAR/SPE/Vig. Cases pending/contemplated/initiated against him.

It will not confer on him any seniority benefits. His name will be continued to be maintained in the original seniority list of regular capacity and he will be considered for promotion on regular basis in the normal channel only.

There shall be no change in the designation, classification or higher status.

He may exercise option for fixation of pay under Rule 1313 (1) (a) (1) of the Indian Railway Establishment Code Volume II (V) Edition 1987 – 2nd Reprint 2005 FR 22 (1) (I) to get his pay fixed in the higher post / Grade Pay either from the date of his promotion/up gradation.


From the date of next increment from 1st July of the year. The pay and the date of increment would be fixed in accordance with clarification No.2 of Railway Board's letter No. PC-V/2008/1/RSRP/1 dated 25.09.2008 (PC-VI/22, RBE No. 132/2009).

He is also entitled to avail Advances, Loans, Passes and PTOs, TA & higher type accommodation based on the pay fixed on financial up gradation.

In case an employee does not exercise any option within one month from the date of issue of this office order, it may be noted that his/her pay will be fixed as 4(a) above.
