The promotion ordered as above, is subject to the following conditions:-

a] उच्चतर जिम्मेदारियों संभालने की तारीख से पदोन्नति प्रभावी होगी।

The promotion will take effect from the date of assuming higher responsibilities.

b] वे अनि/विपुस्था/सतर्कता मामलों से मुक्त है तथा ऐसे कोई दंड नहीं भोग रहे है जो उन्हें पदोन्नति से विवर्जित करें।

The promotion is ordered on the condition that, he is free from DAR/SPE/Vigilance cases and is not undergoing any penalty debarring him from promotion.

c] वे रेलवे बोर्ड के दि.13.11.1981 के पत्र के अनुसार पदोन्नत ग्रेड में वेतन नियतन के लिए विकल्प दे सकते है।

He allowed to exercise option within one month from the date of assuming higher responsibility under 1313 R-II(FR22 I (a)I.

d] वे नियमों के अधीन अनुमेय स्थानांतरण सुविधाओं के लिए अर्ह है।

He is eligible for transfer privileges as admissible under rules.

e] वर्तमान स्टेशन पर यदि वे रेलवे मकान में रह रहे है तो उसे तत्काल खाली करना चाहिए सिवाए कि जब मकान के प्रतिधारण हेतु आवेदन दिया हो। अन्यथा उनके वेतन से क्षति किराए का दर वसूल किया जाएगा।

He should vacate the Railway accommodation,if any, at the present station, immediately

on relief, unless permission is sought for retention of the same. Otherwise damage rate of rent will be recovered from his salary.

The promotion order is subject to outcome of the SLP and contempt Petition No:814/2016 in SLP © No:483/2012 and SLP © No.30621 of 2011 (RBE No:91/2018/PBC No.116/2018).


The employee who is drawing fixation under MACP scheme is not entitled for fixation of pay as he is drawing the promotional benefits under MACP .
