

1. They are free from DAR/SPE/Vigilance cases pending /contemplated/initiated against them..
2. It will not confer on them any seniority benefits. Their name will continue to be maintained in the original seniority list of regular capacity and they will be considered for promotion on regular basis in the normal channel only.
3. There shall be no change in the designation , classification or higher status.
4. They may exercise option for fixation of pay .
 - a) From the date of promotion or
 - b) From the date of next increment in accordance with Railway Board's letter No.PC.-VII /2016/1/6/2 dated 31.07.2017 (RBNo.79/2017) along with office memorandum No. 13-02-2017-Estt (Pay -I)dated 27.07.2017.
5. They are entitled to avail advance, loan, passes and PTO's TA and higher type accommodation based on the pay fixed on financial up gradation. In case an employee does not exercise any option within one month from the date of issue of this office order, it may be noted that his pay will be fixed as 4 (a) above.
6. Any excess payment found to have been made in regard to this order is required to be refunded when detected later by Railways
