The under mentioned candidate who has been selected on compassionate grounds for appointment as TNC, having accepted the terms and conditions stipulated in the offer of appointment and having found medically fit in medical classification AYE TWO and on successful completion of prescribed training for TNC, is absorbed as temporary TNC in Pay Matrix Level-2 in VII PC against regular post and posted as under. His pay is fixed as 19,900/-Pay Matrix Level-2 in VII PC plus usual allowances as admissible from time to time.

समाप्ति स्थानापन्न हैसियत/रिक्ति की समाप्ति या भारतीय संविधान के 311 के उपबंध(2)के प्रावधानों के अनुपालन के बाद अनुशासनिक तौर पर निकाले या बरखास्त किए जाने के कारण है। अन्यथा उनकी सेवाएं दोनों तरफ से 14 दिन की सूचना पर समाप्त की जा सकती है।

His service is purely temporary and he will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India, Otherwise his service is terminable on 14 day notice on either side.

3) रेलवे बोर्ड के दि.10.1.04 के पत्र सं.2004/पी सी 11/21/1 के अनुसार वे अंशदायी पेंशन योजना के अंतर्गत आते हैं। दि.1.1.04 से प्रभावी सरकारी सेवा में कार्यग्रहण करने वाले केन्द्र सरकार सेवा के सभी नए रिक्त अनिवार्य तौर पर सरकार को अंशदान करेंगे। टीयर 1 के लिए रेल कर्मियों से देय अंशदान प्रति महीने उनके वेतन से उनके मूल वेतन तथा महंगाई भत्ते के 10% दर पर वसूल किया जाएगा।

In terms of Railway Board's letter No.2004/PC11/21/1 dated.10.01.04 he is coming under Contributory Pension Scheme. All the new recruits in the Central Government Service joining Government Service with effect from 01.01.04 shall compulsorily make contribution to the Government. The contribution payable by the Railway servants towards the Tier I will be recovered at the rate of 10% of Basic pay and DA from his salary every month. In addition to above pension account, each Government servants may also have Tier II with draw able account at their option.

5) His appointment is purely provisional subject to the recruitment verification reports received from Civil/police authorities regarding his character and antecedents. If anything adverse is found in the said report regarding the suitability for appointment in Government Service, he is liable to be terminated summarily.
