- 6) He is eligible for all the transfer privileges .
- 7) The promotion is ordered on the condition that there are no prima facie cases pending against him as a result of fact finding or otherwise and that he has not been placed under suspension or no departmental proceedings have been initiated against him not proposed to initiated proceedings at an early or he is not undergoing any penalty debarring him from promotion.
