The above appointments are subject to the following conditions:-

- 1) They will be on probation for a period of 2 years from the date of appointment.
- 2) Their service is purely temporary and they will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India, Otherwise their service is terminable on 14 days notice on either side.
- 3) In terms of Railway Board's letter No.2004/PC11/21/1 dated.10.01.04 he/she is coming under Contributory Pension Scheme. All the new recruits in the Central Government Service joining Govt.Service with effect from 01.01.04 shall compulsorily make contribution to the Government. The contribution payable by the Railway servants towards the Tier I will be recovered at the rate of 10% of Basic pay and DA from his/her salary every month. In addition to above pension account, each Govt. servants may also have Tier II withdraw able account at their option.
- 4) Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway.
- 5) All other terms and conditions stipulated in this office offer of appointment stands good.
