The inter Divisional mutual transfer of Shri. Dhanuraj. P (SC),ALP/CCRC/O/PGT, PGT Dvn in Pay Level 2, with Shri. Anil Kumar Ram (SC) , ALP/ERS, TVC Division as ALP in Pay Matrix Level-2 has been agreed to by the competent authority viz DRM/PGT. 
The above mutual transfer is ordered subject to the following conditions.

- 1) They will not seek re-transfer to their parent Division/unit at a later date.
- 2) As the transfer is ordered at their request, they will not be eligible for transfer privileges like transfer passes, transfer allowances, joining time etc.
- 3) They will retain their lien in the parent Division till they are permanently absorbed in the new seniority to which they are posted.

- 4) There are no DAR/SPE/Vigilance cases pending against them on the date of relief.
- 5) The relieving Memorandum/order sparing the employee should have the photograph of the employee pasted on it duly attested in the manner viz the rubber stamp should clearly indicate the name and designation of the supervisor/ Officer. The memorandum/order should also have the signature of the transferred employee and his left thumb impression both of which should be duly attested by the officer signing the memorandum/order with his name and designation appearing below the signature as stipulated in Railway Bd's letter No E (NG) 1-2001/ TR-16 dtd 21.11.2011 (RBC NO229/2001)
- 6) They should vacate Railway Quarters immediately on relief, if any, occupied by them. If they propose to retain the quarters as per extant orders, they should apply in time for retention and obtain prior permission. Retention of Railway quarters without/beyond permission will attract deduction of damaged rate of rent.

This has the approval of the competent authority.
