DRM/PGT has accorded approval for the appointment of the following ex-Servicemen to Level One posts on full time Contract basis. The following Ex-Servicemen , having accepted PCPO/MAS office offer of engagement issued to them to Level One posts on Pay Rs.18000/- plus allowances DA,TA,HRA & Dress allowance of RS.5000/- per annum (wherever applicable) on "Full time Contract basis " and having executed the contract agreement are engaged as ,Assistant in Electrical Department (GS) in PML 1. They have been posted to station noted against each


The above engagement as Assistant in Electrical Department (GS) on full time contract basis is subject to the following terms and conditions:

1. The contract of Ex-Servicemen for Level 1 Posts are on full time basis and shall not be entitled for Railway Quarters and Privilege/Complimentary Passes etc.
2. Duty Pass may be provided for stretch of the journey involved on duty. They may be entitled to II class 'A' duty pass.
3. The contractual staff may be permitted weekly off and National Holidays . However they may be called for duty on any day including National Holidays for which Compensatory Rest may be given later.
4. These contract engagements are against clear vacancies of Direct Recruitment Quota for a maximum period of one year or availability of a regularly selected

- candidate, whichever is earlier. Suitable breaks will be given between successive contracts (if any).
5. The contract may be terminated on either side by giving 15 days notice. The performance monitoring of contractual appointees will be done on regular basis and those who are unable to discharge the duties or who fail to perform as per expectations of the administration may be given 15 days notice and their contract shall be terminated. However when contract staff is found to be mentally or physically incapacitated and in case of gross negligence / misconduct / misbehavior / irregularities , the engagement contract may be terminated with immediate effect.
 6. The engagement on contract basis will not confer any right to claim for regular absorption /extension in Railways.
 7. They may be paid Daily Allowance when on tour as admissible at the rate of Rs.500/-.
 8. In case of absence for duty proportionate amount of pay per day will be deducted . If full time contract Ex-Servicemen are on unauthorized absence beyond 3 days , their engagement will be automatically be terminated.
