Her appointment is subject to the following conditions:

1. Her initial engagement in Railways will be as Substitute and she is eligible for grant of temporary status only after completing 4 months continuous service as substitute.

2. Her service will be terminated, if her work is found to be unsatisfactory or if her services are not required by the officer/her successor or any other administrative officer within 3 years.

3. Her seniority will be fixed in the Group D cadre on completion of 3 years of continuous service i.e. regularization of service will be made only after completion of 3 years continuous service **after attaining temporary status**.

4. On completion of 3 years service, if her services are not required in the Bungalow due to transfer of the Officer concerned (or) on deputation for foreign training exceeding 3 years (or) Superannuation (or) V .R or by her successor, her regularization will be in the Open Line, in other than Peon or Office category.

5. She should not resign or quit her employment except with the previous consent of the competent authority or office in which she is employed, that too in writing.

She should abide by all rules and conditions of the Railway Service Conduct Rules, 1966 as amended from time to time on attainment of temporary status.


6. She will be held responsible for charges and custody of Govt. money, goods and stores and all other properties that may be entrusted to her.

7. She will be governed by the Contributory Pension System introduced with effect from 1.1.2004, for new entrants to Central Government Service (including Railway Service), as envisaged in Railway Board's letter No: F(E) III/2003/PN-1/24/RBE No:225/2003) dated 31.12.2003 and as amended from time to time, from the date of his regular absorption in Group D cadre.

8. Notwithstanding the conditions detailed above, the newly engaged candidate will be governed by all other conditions and rules prescribed under HQrs office Circular No. PB/CS/153 dated 12.12.2002 and subsequent instructions/ amendments being issued/made from time to time.

9. She has been certified medically fit in Bee One vide Sr.DMO/RH/PGT Medical Certificate No. A 029574 – C1/06/2020 dt. 15.01.2020.
