



The re-engagement order in favour of the above employee is subject to the following conditions:

1. The Scheme is operative only till 01.12.2020 unless and until extended by Railway Board through further instructions.
2. Re-engagement is purely on temporary basis and his services will be terminated as and when suitable regular incumbents joins the post either by way of recruitment or by transfer or the categories for which Zonal Railways are permitted to utilize the employee on contract basis viz. Ex-servicemen or **on attaining the age of 65 (Sixty five) whichever is earlier** or on cessation of the scheme or due to surrender of post due to manpower planning.
3. Monthly remuneration of the Re.-engaged retired Railway Staff will be governed in terms of Board's letter No.E (NG)II/2007/RC-4/CORE/1 dated 24.10.2019 (PBC No.258/2019).
4. The applicants should not have been covered under LARSGESS or any other like schemes.
5. The working hours of re-engaged staff will be same as that of the regular staff in similar post.
6. Remuneration will be calculated only on **monthly basis**. As per RBNo.39/2017 **re-engaged staff when sent on duty outside the station /Headquarters are eligible for daily allowances at the rate of 60 % of the applicable DA rate. The weekly rest and General Holiday observed in the respective office are to be followed for the re-engaged employee also.**
7. The period of such re-engagement will not be counted as service for any purpose as admissible to regular serving employees.
8. Re-engaged staff will not be covered for any coverage under ECA, PWA, payment of Gratuity Act or any other statutory enactment admissible to serving Railway employees.
9. Re-engaged staff will not be entitled for PLB or any other extra benefits admissible to serving employees.
10. Re-engaged staff will not be covered by any of the welfare Scheme, CGA, Ex Gratia, Funeral Advance etc. as admissible to regular employees.
11. Re-engaged staff will not be entitled for any advances as admissible to regular employees.
12. The above re-engagement will take effect from the date of his joining the post.



13. He is eligible for 08 days leave (on pro-rata basis) in a calendar year on contractual arrangement in terms of PBC No. 166/2019.
14. The above employee is free from DAR /SPE/Vig. Cases
15. The date of joining may be advised to all concerned.
