1. They will rank junior most in the new seniority unit in the PML-1 (GP ₹ 1800/-) and will be placed below all the existing Helper/STM working in the above PML-1 as on date of joining the new depots in Engineering/Southern Railway and their seniority will be assigned from 07.3.2020 & 09.3.2020 i.e. the date on which their reported at Southern Railway/Palakkad Division.
2. They are free from DAR/SPE/Vigilance cases on the date of relief.
3. They should not seek re-transfer to her parent Railway ie. Western Railway at a later date.
4. They will retain their lien in the present Department/Seniority unit till they are permanently absorbed in the new seniority unit to which they are transferred.
5. They are not eligible for any transfer privileges, like joining time, composite Transfer Grant, pass, etc. Since the transfer is ordered at their request.
6. They are posted to Helper/STM at SSE/P.Way/TIR & West/PTJ in PML-1 (GP ₹ 1800/-), VII PC.
