Para I : Promotional Transfer

The above promotion is subject to the following conditions:

a) They should advise their willingness or otherwise to this office within 15 days from the date of receipt of this Office Order. Failure to do so, i.e if they are not willing to carry out promotion, the same will be treated as refusal of promotion and consequently they will be debarred from promotion and not eligible to be considered for promotion before the expiry of one year and that they will lose place to all their juniors who are promoted in the meanwhile.

b) There are no DAR/SPE/Vigilance cases pending against them and that they are not undergoing any punishment debarring them from promotion.

c) The above promotion is subject to the outcome of the Main SLP and Contempt Petition No.(C) 314/2016 in SLP (C) No.4831/2012 pending before the Hon'ble Supreme Court and other cases pending before various other courts and also subject to further clarification on Board's letter No. RBE.22/2018 dtd 16.02.18.

d) Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway.

e) The above promotions will take effect from the date of their assuming higher responsibilities. Date of assuming higher responsibilities may be advised to all concerned in time.

f) They are allowed to exercise option for fixation of pay within a period of one month from the date issue of office order under Rule 1313 FR 22(I)(a)(I)R II.

g)The date of relief/joining/assuming higher responsibilities of the above employee may be advised to all concerned in time.

The following SS & SM'S are transferred and posted to the stations noted against each **on their request** in the same Level of Pay Matrix.


