b. Their pay on promotion may be fixed initially at the stage on a time scale of the new post above the pay in the lower post, which may be re-fixed on the basis of the provisions of Rule 1313 (FR22 (I) (a) (i)) on the date of accrual of next increment in the scale of the lower post.
