Sub: Promotion to the post of Station Superintendent in Pay Matrix Level-07 and request transfer of Station Superintendent-Reg.

(a)The employees transferred on request are not eligible for any transfer privileges since their transfers are ordered at their request.

(b)The date of relief/joining/assuming higher responsibilities of all the above employees may be advised to all concerned in time and also the details of employees who have not joined on transfer within 15 days from the date of relief.

(c)The employees under orders of transfer should vacate Railway Quarters immediately on relief if any occupied by them. If they propose to retain quarters as per extant orders, they should apply in time for retention and obtain prior permission. Retention of quarters without / beyond permission will attract deduction of damaged rate of rent.

The above promotion is subject to the following conditions:

a) He should advise his willingness or otherwise to this office within 15 days from the date of receipt of this Office Order. Failure to do so, i.e if he is not willing to carry out promotion, the same will be treated as refusal of promotion and

consequently he will be debarred from promotion and not eligible to be considered for promotion before the expiry of one year and that he will lose place to all his juniors who are promoted in the meanwhile.

b) There are no DAR/SPE/Vigilance cases pending against him and that he is not undergoing any punishment debarring him from promotion.

c) The above promotion is subject to the outcome of the Main SLP and Contempt Petition No.(C) 314/2016 in SLP (C) No.4831/2012 pending before the Hon'ble Supreme Court and other cases pending before various other courts and also subject to further clarification on Board's letter No. RBE.22/2018 dtd 16.02.18.

d) Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway.

e) The above promotion will take effect from the date of assuming higher responsibility. Date of assuming higher responsibility may be advised to all concerned in time.

f) He is allowed to exercise option for fixation of pay within a period of one month from the date issue of office order under Rule 1313 FR 22(I)(a)(I)R II.

g) The date of relief/joining/assuming higher responsibilities of the above employee may be advised to all concerned in time.
