2) The above promotions are provisional subject to the outcome of the various cases pending in the Courts. In terms of RBE 117/2016, the promotions are subject to the outcome of the pending contempt petition Civil No.314/2016 and SLP Civil No.4813/2012

3) वे 12 महीने की अवधि के लिए परिवीक्षा में होंगे। यदि उनका निष्पादन संतोषजनक नहीं पाया गया तो परिवीक्षा अवधि की समाप्ति पर उन्हें पुराने पद को प्रत्यावर्तित किया जाएगा। They will be on probation for a period of 12 months. If their performance is not found satisfactory at the end of the probation period they are eligible to be reverted to their original post.

4) स्वतंत्र तौर पर कार्य संभालने की तारीख सभी संबंधितों को यथासमय सूचित की जाए। the date of taking independent duty may be advised to all concerned in time.

5) Those who are drawing fixation under MACP Scheme is not entitled for fixation of pay as they are drawing the promotional benefits under MACP .The promotion of the above employee will take effect from the date of assuming higher responsibilities.



They should advise their willingness or otherwise to this office within 15 days from the date of receipt of this office order. Failure to do so, i.e. if he is not willing to carry out promotion, the same will be treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year and that they will lose place to all their juniors who are promoted in the meanwhile & will be debarred from promotion for one year from the date of issue of the order.

7) The above employees are charged against 'UR' points.

8) " Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway."
