Absorption of the employees in the alternative post will be governed by extent rule for seniority and fixation of pay for staff absorbed in alternate posts on medical ground.

Railway Board in the letter No.E (NG)1/98/RE-3/9 dated 11.12.2000 has declared that once a suitable appointment with the same pay and scale and service benefits enjoyed by the Railway servant before decategorisation is offered no option is available to medically decategorised employee to decline the alternative employment immediately the payment of salary to her against supernumerary post will be discontinued forthwith.

They should vacate the railway accommodation, if any, at present station immediately on relief unless permission is sought for retention of the same. Otherwise, damage rent will be recovered from their salary.



The employees should carry out transfers/posting within a reasonable period of two weeks and it is the responsibility of the supervisors concerned to relieve the staff immediately.

The date of relief/joining may be advised to all concerned promptly.
