1. The following inter Divisional Mutual transfers are ordered with immediate effect.

(a) Shri. Vijaya Vignesh. R, Goods Guard/CAN of PGT Division, in Pay Matrix Level-5 (GP 2800-), PF No 29801183 is transferred with Shri. M.J. Jamesh Goods Guard/MDU, in Pay Matrix Level -5 (GP 2800/-), PF No 15429801411 of Madurai Division vice item No 2.

(b) Shri. M.J. Jamesh Goods Guard/MDU, in Pay Matrix Level -5 (GP 2800/-), PF No 15429801411 of Madurai Division is transferred with Shri. Vijaya Vignesh. R, Goods Guard/CAN of PGT Division, in Pay Matrix Level-5 (GP 2800-), PF No 29801183 vice item No 1 above.

Shri. M.J. Jamesh Goods Guard/MDU, in Pay Matrix Level -5 (GP 2800/-), PF No 15429801411 of Madurai Division has been relieved from Madurai Division on 26.08.2020 and reported this Division on 11.09.2020 (F/N) after completion of Quarantine period. Sr. DOM/PGT has directed him to CAN to take line training between CAN to MAQ-PNMB section and CAN –PGT section. After completion of line training he is posted as Goods Guard/CAN in his present pay and allowance in Pay Matrix Level -5 (GP 2800/-).

उपरोक्त इकतरफा अंतर मंडल स्थानंतरण तत्काल प्रभाव से आदेशित है और निम्नलिखित शर्तों पर निर्भर है

The above inter Divisional Mutual transfer is ordered subject to the following conditions:-

1. नई इकाई में उनकी वरिष्ठता ऐसे स्थानांतरणों को लागू वर्तमान नियमानुसार नियमित की जाएगी। याने वे या तो अपनी वरिष्ठताया नई वरिष्ठता इकाई में दूसरे की वरिष्ठता इनमें से जो निम्नतर हो लेंगे।

The seniority in the new unit will be regulated, as per extant orders applicable to such transfer. ie, they will either retain their own seniority or take the seniority of the other in the new unit to which they are posted whichever is lower.

2. वे अनु अ नि/विपुस्था/सतर्कता मामलों से मुक्त है।

The above employees are **free from DAR/SPE/Vigilance cases on the date of relief.**

3. उन्हें बाद में अपने मूल मंडल को पुननांतरण के लिए आवेदन नहीं देना चाहिए। स्था :

They should not seek retransfer to the parent division/unit at a later date.

4. वे स्थानांतरण सुविधाओं जैसे कार्यग्रहण समय नांतरण अनुदान पास आदि के लिए पात्र स्थासंयुक्त , नहीं है।

They are not eligible for any transfer privileges, like joining time, composite transfer grant, pass, etc.

5. कार्यमुक्ति पर वर्तमान स्टेशन में यदि रेलवे आवास में रहते हो तो उसे खाली करना होगा अन्यथा उसको अनधिकृत अधिभोग माना जाएगा और अनु अ नि के अधीन समुचित कार्रवाई ली जाएगी।

They should vacate the Railway quarters, if occupied, immediately on their relief. Failure to comply will be treated as unauthorized occupation and appropriate action will be taken under DAR.

6. उनको स्थानांतरित नई वरिष्ठता इकाई में कहीं भी काम करने के लिए उनको तैयार होना चाहिए।

They are prepared to serve anywhere in the new seniority unit.

7. रेलवे बोर्ड के पत्र संई. (एनजी)2001-आईआर/16 दि. 21.11.2001 के अनुसार इस स्थानांतरण को कार्यान्वित करना चाहिए।

The transfer is to be carried out in terms of Railway Board's letter No.E(NG)1-2001/TR/16 dated 21-11-2001 (RBE No . 229/2001).

8. The employees should handover all the materials pertaining to Railway which were entrusted to them in the course of their work, to their immediate supervisor. While relieving the employee the relieving memo should consist of the recent photograph, specimen signature and identification marks duly attested by the officer signing the releasing memorandum/Order with Officer name and designation appearing below the signature (As stipulated in Railway Board's letter No E(NG)1-2001/TR/16 dated 21.11.2001 (RBE NO 229/2001).
