Sub: Absorption of employee in alternate post on medical grounds.

The following employee who has been kept on supernumerary post due to medical decategorisation and subsequently being found fit in medical classification in Cee One and below is absorbed in the alternative post noted against him and posted to the station mentioned below:

The absorption of the employee in the alternative post will be governed by extant rules for seniority and fixation of pay for staff absorbed in alternative post on medical grounds.

Railway Board vide Letter No.E(NG) 1/98/RE-3/9 dated 11.12.2000 have declared that once a suitable appointment in the same pay and scale and service benefits enjoyed by the Railway servant before decategorisation is offered, no option is available to a medically decategorised employee to decline the alternative employment to which he/she is posted. Therefore if he does not take up the alternative employment immediately, the payment of salary in his favour against the supernumerary post will be discontinued forthwith.

The employee should carry out his transfer / posting within a reasonable period of two weeks and it is the responsibility of the supervisor concerned to relieve the staff immediately.

He should vacate the railway accommodation if any, at the present station immediately, on relief unless permission is sought for retention of the same. Otherwise damage rent will be recovered from his salary

The date of relief / joining may be advised to all concerned immediately.

This has the approval of Competent Authority.
