
Smt.Vijaya Kannuru, who was engaged as Substitute Bungalow Peon to Shri.Sakkeer Hussain.C.T, ADRM/PGT vide office order under reference (1) and has completed 120 days continuous service with effect from the date mentioned below, is granted the benefit of temporary status w.e.f 19.09.2020(Excluding 14 days quarantine period: 03.07.2020 to 16.07.2020) on pay Rs.18,000/- in Level - 1 of Pay Matrix (Pre-revised PB Rs.5200-20200 with GP Rs.1800/-).

As per extant orders, she is eligible for all the privileges as applicable to temporary Railway servants on and from the date of grant of temporary status. The grant of temporary status will not, however, confer on him any claim for continuance in the grade and absorption in any regular establishment for which she is to get herself selected by a constituted selection board/committee.

She will be governed by the new contributory pension system which is mandatory and has been introduced for those who were appointed on or after 01.01.2004 as per Boards' Letter No. F (E) III/2003/PNI/24 dt 31.12.06.
