Shri.SafeerThorappa (UR), Goods Guard/JRU, in Pay Matrix Level -5 (GP 2800/-), PF No 426-10D00200 of Mysore Division, South Western Railway is transferred to PGT Dvn/S.Rly as Goods Guard on his same pay matrix Level and pay on Inter Railway one way transfer on bottom seniority. Having been relieved from Mysore Division on 05.10.2020 he has reported at PGT Division on 20.10.2020 (F/N) after completion of Quarantine period. He has been nominated for online RC by Sr. DOM/PGT. He has reported for On line RC course on 21.10.2020. He is posted as Goods Guard/CAN after completion of his RC in his present pay and allowance in Pay Matrix Level -5 (GP 2800/-). 1. नई इकाई में उनकी वरिष्ठता ऐसे स्थानांतरणों को लागू वर्तमान नियमानुसार नियमित की जाएगी। याने वे या तो अपनी वरिष्ठताया नई वरिष्ठता इकाई में दूसरे की वरिष्ठता इनमें से जो निम्नतर हो लेंगे।

The seniority in the new unit will be regulated, as per extant orders applicable to such transfer. ie, he will place in the bottom seniority of Goods Guard

2. वे अनु अ नि/विपुस्था/सतर्कता मामलों से मुक्त है।

The above employee is free from DAR/SPE/Vigilance cases on the date of relief.

3. उन्हें बाद में अपने मूल मंडल को पुनः स्थानांतरण के लिए आवेदन नहीं देना चाहिए।

He should not seek retransfer to the parent division/unit at a later date.

4. वे स्थानांतरण सुविधाओं जैसे कार्यग्रहण समय , संयुक्त स्थानांतरण अनुदान पास आदि के लिए पात्र नहीं है

He is not eligible for any transfer privileges, like joining time, composite transfer grant, pass, etc.

5. उनको स्थानांतरित नई वरिष्ठता इकाई में कहीं भी काम करने के लिए उनको तैयार होना चाहिए।

He is prepared to serve anywhere in the new seniority unit.

6. रेलवे बोर्ड के पत्र सं. ई(एनजी)2001-आईआर/16 दि.21.11.2001 के अनुसार इस स्थानांतरण को कार्यान्वित करना चाहिए।
