- 1) The Volunteers are called for from the category of Station Masters/Traffic Inspector working in same Pay Scale of Headquarters /Divisions
- 2) The Volunteers on posting will work normally for a period of four years and their lien and seniority will be maintained at their respective divisions.
- 3) Staff who has once completed their tenure on any other ex-cadre post in any department should have worked at least for a minimum period of Two years in their parent cadre. (Mandatory cooling off period between postings in 2 ex-cadre posts).
- 4) The priority will be given first to volunteers from HQrs and MAS Divn. for Sl.No.1and PGT, TVC Division for SI.No.2.
- 5) Other division volunteers would be considered only if suitable persons are not available from HQrs. &Chennai Division & PGT, TVC Division.
- 6) Their selection will be on the basis of scrutinizing service records for experience and required skill to work at Construction Unit /Chennai.
- 7) The willing employees may apply in the enclosed format on or before 15/11/2020.
- The application shall be forwarded by the controlling officer through respective Personnel Officers of the Division /Hqrs. ...2

- 9) While forwarding applications, cadre Personnel officer should certify on the applications that the employees are free from DAR/SPE/VIG cased and if selected, they should be spared to CN Units at short notice without fall and only such applications must be forwarded. If the Branch Officer is not in a position to relieve the employee on selection advice, such applications need not be forwarded. Once it is forwarded, Branch Officers shall not express their inability to relieve the employee on any reasons at a later date.
- 10) The lien of the selected employees will continue to be maintained in their parent unit.
- 11) The selected employee should have minimum 3 years of residual service as on 15.10.2020.
- 12) The selected employee will be repatriated to the parent division one year before retirement on Superannuation No request for retention during that one year period will be entertained and settlement cannot be made at HQ under any circumstances. Wide publicity may be given to this notification. All the applications shall be forwarded to HQrs, from Divisions in a single bunch on or before 18/11/2020 if there are no volunteers for the above posts, a "NIL" reply may be sent this office.
