His appointment is subject to the following conditions:-

- 1) He will be on probation for a period of 2 years from the date of appointment.
- 2) His service is purely temporary and he will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India, Otherwise his service is terminable on 14 day notice on either side.
- 3) In terms of Railway Board's letter No.2004/PC11/21/1 dated.10.01.04 he is coming under Contributory Pension Scheme. All the new recruits in the Central Government Service joining Government Service with effect from 01.01.04 shall compulsorily make contribution to the Government. The contribution payable by the Railway servants towards the Tier I will be recovered at the rate of 10% of Basic pay and DA from his salary every month. In addition to above pension account, each Government servants may also have Tier II with draw able account at their option.
- 4) Salary will be claimed through nationalized bank. He may submit the SB Account Number.
- 5) His appointment is purely provisional subject to the recruitment verification reports received from Civil/police authorities regarding his character and antecedents. If anything adverse is found in the said report regarding the suitability for appointment in Government Service, he is liable to be terminated summarily.
- 6) All other conditions are as stipulated in this office offer of appointment.
- 7) Staff Number & P F No assigned should be quoted in all correspondence.
- 8) The period from 18.02.2021 to 10.03.2021 the date of joining the station to which posted is treated as extended period of training.
