3. There shall be no change in the designation, classification or higher status.

4. They are eligible to exercise option for fixation as mentioned below.

Pay fixation under Rule 1313(1) (a) of the Indian Railway Establishment Code Volume II (VI Edition 1987- 2nd reprint 2005)FR 22(1)

(a) to get her pay fixed in the grade pay either from the date of his up gradation.

OR

(b) From the date of their next increment from 1st July/ January of the year. The pay and the date of increment would be fixed in accordance with clarification no.2 Railway Board's letter No.PC-VI/2008/1/RSRP/1 Dtd.25.09.2008 (PC-VI/22 RBE No.132/2008).

5. They are also entitled to avail Advances, Loans, Passes and PTOs, TA & higher type of accommodation based on the pay fixed on financial up gradation.

The above fixation is subject to verification and in the light of audit observation, excess payment made, if any, either in the form of arrears or otherwise shall be recovered either by adjustment against future payment due to the employee without any future notice.
