Para I: One vacant post of Station Superintendent from WRA and one vacant post of Station Superintendent from CAN are transferred temporarily to MDKI and MAQ respectively for a period of one year from the date of operation.

Para II: The following Station Masters in Pay Matrix Level-6 are promoted as Station Superintendents in Pay Matrix LLevel-7 against the existing vacancies and posted to the station as indicated against each.

The above promotions are ordered subject to the following conditions:

1. They will be on probation for a period of 12 months from the date of entry in the promotion grade. Continuance of promotee in the promoted grade will depend on their performance and successful completion of probation period as per Para 113 of IREM & Railway Board's letter No.E(NG) I-98/CN5/1 Dtd.02.08.2001 (RBE No.148/2001 & PBC No.135/2001). Non completion of probation period is a failure on the part of promotee. In case, before the successful completion of probation period in the promoted grade if the promotee seeks transfer to a post from which they were promoted, their pay in lower grade/ post on such reversion will be fixed at a stage what they would have drawn had he/she not been promoted.
2. The above promotions are ordered subject to the condition that the employees are not undergoing any penalty debarring them from promotion and are free from DAR/SPE/Vigilance cases. In case, if the employees is undergoing any penalty at the time of their promotion it will be deemed that they are carrying out current duties till such time they becomes free from punishment.
3. The above promotion order is provisional and issued subject to outcome of main SLPs and Contempt Petition ©No.314/2016 in SLP ©No.4831/212 & subject to outcome of other cases pending before various Central Administrative Tribunals and Courts of India.
4. The above promotion will take effect from the date of assuming higher responsibilities. In case, if the employee is not willing to be promoted within the period of 15 days from the date of receipt of orders, the same will be treated as refusal of promotion and they will be debarred for promotion for a period of one year from the date of issue of this order and consequently they will not be eligible to be considered for promotion before expiry of one year from the date of refusal and they will lose place to all juniors who will be promoted in the meanwhile.
5. The above employees are allowed to exercise option within a period of one month from the date of assuming higher responsibility under Rule 1313R II (FR-22(1)(a)(1). In case they do not exercise any option within the stipulated period, it may be noted that their pay will be fixed as envisaged under Rule 1313R II (FR 22(1)(a)(i) and no further option/ revision is permissible as envisaged in Railway Board's letter No.CVII/2016/1/6/2 Dtd.31.07.2017 (PBC No.115/2017).
6. In case were financial up-gradation under ACP/ MACP scheme already granted and pay fixed accordingly no further pay fixation will arise at the time of regular promotion. If the level in the Pay Matrix at the time of financial up-gradation under MACP's is different than what is available in the normal hierarchy at the time of regular promotion in one's own AVC, then the higher level in the Pay Matrix attached to the next promotion post in the hierarchy of the concerned cadre/ organization will be given only at the time of regular promotion in terms of RBE No.155/2016 Dtd.19.12.2016.
7. The actual date of shouldering higher responsibility in respect of the above employees should be advised to all concerned at the earliest.
8. The employees mentioned above are eligible for all transfer privileges.

Para III: Sri.N.P.P Mohanachandran, SM/MHE who has declined his promotion as Station Superintendent/ Operating Department in Pay Matrix Level-7 and continuing as station Master in Pay Matrix Level -6 is debarred for further promotion for a period of one year from 09.04.2021 ie. from the date of issue of promotion order referred above and

retained at his present station in his existing Pay Matrix Level-6. He will be considered for promotion only after one year subject to availability of vacancies. He will lose place of seniority to his juniors who are promoted in the meanwhile. He is allowed to continue in the present grade.
