
*- As per Para 6 of Railway Boards Circular No.212/2019 dated 18.12.2019 circulated vide PBC No:308/2019, employees who have promoted on or after 01.01.2016 and exercised option B, are eligible for one increment on completion of 06 months subject to the condition that they should have six months qualifying service from the date of increment.

The above up gradation is subject to all the terms and conditions as laid down in Board's letter cited, such as

1. They are free from DAR/SPE/Vig.Cases.
2. It will not confer on them any seniority benefits. Their name will be continued to be maintained in the original seniority list of regular capacity and they will be considered for promotion on regular basis in the normal channel only.
3. There shall be no change in the designation, classification or higher status.
4. They are also entitled to avail Advances, Loans, Passes and PTOs, TA & higher type of accommodation based on the pay fixed on financial up gradation.

The above fixation is subject to verification and in the light of audit observation, excess payment made, if any, either in the form of arrears or otherwise shall be recovered either by adjustment against future payment due to the employee without any future notice.
