Their engagement is subject to the following conditions:

1. Part time Post Graduate teacher will be engaged on contract basis for teaching for teaching Biology and Mathematics for classes Plus One & Plus Two. Part time Trained Graduate Teacher will be engaged on contract basis for teaching Hindi & English for classes in High School sections.

2.They should perform all jobs related to academic including evaluation work for which no payment over and above the one for taking period will be paid.

3.Part Time Post Graduate Teachers will be paid consolidated monthly pay of Rs.27,500/- and Part Time Trained Graduate Teachers will be paid a consolidated monthly pay of Rs.26,250.

4.They will not be entitled for any other facility like leave, medical passes, PTO's, transportation etc. as admissible to regular teachers.

5.They will not be entitled as Railway Teachers and will have no claim or right for appointment on regular basis and will not form part of the cadre of Railway Teacher Declaration has to be given to this effect.

6.Their engagement as part time teachers on contract basis will be done for a period of not less than 7 days and not more than 200 working days .Their service will be terminated at any time without assigning reason.

7.They will be held responsible for the charge and case of Government money, goods and stores and all other property that may be entrusted to them.

8.They have to abide any other conditions stipulate by Railway administration on time to time.

9.They have to submit a declaration to the effect that are accepting the above conditions.

10.Teachers appointed on contractual basis will not be entitled for vacation pay and during Autumn/Winter Break, payment will be calculated on the pro rata basis. Contract teacher appointed for a period of less than a month will be paid on pro rata basis.

They are directed to report to RHSS/PGT on or before 11.08.2021.Their date of joining may be advised to this office.
