It is proposed to conduct a selection for the post of Cash Van Driver Grade III in Level 2 of VII CPC Pay Matrix (VI CPC PB-1 with GP of Rs.1900) against **2 (TWO) vacancies (1-UR and 1-ST)** in the office of Dy.CAO/ Cash & Pay/MAS. The proforma of the application for the above post is enclosed.

**{1} CONDITIONS OF ELIGIBILITY:**

- {1.1} All Group C & D employees with minimum 3 years of regular service as on 18.08.2021, i.e., the date of notification, in the Levels 2 and 1 of VII CPC Pay Matrix (PB – 1 with either of the Grade Pays Rs.1900 or Rs.1800 of VI CPC), are eligible to apply for the above mentioned post.
- {1.2} The employees who are willing to apply for the above post should have Heavy Vehicle Licence (four wheeler) with minimum validity up to August 2024, issued by the Regional Transport Authority of the State Government.
- {1.3} The employees who are willing to apply should forward the application along with the certified copy of proof for educational qualification and attested copy of Community Certificate, in case of SC/ST employees.
- {1.4} All the applications should be routed through the Cadre controlling officers, along with a No Objection Certificate for participation in the Selection.
- {1.5} Only those who are eligible for BEE-ONE medical examination, should apply for the above post.
- {1.6} The employees should undergo a trade test to be conducted by CWM/RT/CW/PER.



- {2} The candidates who respond to this notification should be ready to attend both Trade Test and Medical examination, through their respective controlling officer, on advice from this office.
- {3} The Service Registers, duly updated, as well as the Vigilance clearance certificate of the applicants should be kept ready for immediate transmission to this office, whenever called for.
- {4} The Controlling Officer should verify the particulars furnished in the application of the employee and also certify that there are no DAR/SPE/VIG cases pending/ contemplated against the employee, before forwarding the same.
- {5} Wide publicity may be given by the concerned units.
- {6} Last date for receipt of filled in applications is 08.10.2021. The applications should reach the following address, in a single bunch, **on or before 08.10.2021**, positively.
