Sri. AnilKumar who is the senior to Sri. Satheesan Kovval (Sl. No13) has considered for promotion due to non receipt to SR /APAR from W.Rly on receipt of the so his promotion will be considered as Tech Gr.I/C&W

- 1) They are not undergoing any penalty debarring them from promotion and are free from DAR/SPE/Vigilance cases. In case any of the employees are undergoing any penalty at the time of their promotion it will be deemed that they carry out current duties till such time they become free from punishment.
- 2) The employees promoted above shall carry out their promotion within 15 days from the date of issue of this order and failure to do which will be treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year debarment period and they will lose seniority to their juniors promoted in the mean while.
- 3) The fixation of pay on promotion from one level to another is fixed in terms of (RP) rule, 2016 13 (i).
The above named employees may exercise option for fixation of pay to get their pay fixed in the higher level either
From the date of promotion or
From the date of next increment in accordance with railway Board's letter No PC-VII/2016/1/6/2 dt.31-07-2017 (RBE No 79/2017) along with office Memorandum No 13-02-2017-Esst.(Pay-1) dated 27-07-2017., within one month from the date of issue of this O.O.
- 4) The employees who are in receipt of Financial up gradation under MACP Scheme 2008 in the promoted pay matrix Level are not entitled for further fixation pay on promotion.
- 5) The above promotion is subject to the outcome of main SLP and contempt petition No(C) 314/2016 in SLP (C) No.4831/2012 pending before the Hon'ble Supreme Court and other case pending before various other courts and also subject to further clarification on Board's letter No.RBE.22/2018 Dt.16/02/2018.
- 6) The employee who are under orders of promotion transfer are eligible for all transfer privileges.
- 7) The promotions are ordered on the condition that there are no prima facie cases pending against them as a result of fact finding or otherwise and that they have not been placed under suspension or no departmental proceedings have been initiated against them or not proposed to initiate proceedings at an early date or they are not undergoing any penalty debarring them from promotion.
- 8) Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway.
- 9) The employee under orders of transfer should vacate the Railway quarters immediately on relief if any occupied by them. If they propose to retain the Qtrs. under the extend order, they should apply in time or retention and obtain proper permission. Retention of Quarters without / beyond permission period will attract damage rate of rent.

10) The above promotions will take effect from the date of their assuming higher responsibility.

11) There is a probation period of one year in the promoted grade if their performance are not found satisfactory at the end of the probation period, they will be reverted to the original grade.

The date of relief/joining of the employees may be advised to all concerned.
