Sub: Financial Up gradation under MACP Scheme

In terms of RBE No:26/2020 dated 25.02.20(PBC No:29/2020 dated 27.02.2020) and PBC No:76/2020 dated 18.05.2020, promotion to the post of ASM (GP Rs.2800) to SM (GP Rs.4200) may not be reckoned for the purpose of MACPS and the benefit of MACPS ignoring promotion from ASM to SM shall be admissible from 16-02-2018.

Further to the above, accordingly, Financial up gradation under Third MACP granted to PML-8 (GP 4800) is treated as IIInd MACP and the employee has been granted IIIrd MACP in to Pay Matrix Level-9 (GP 5400) from the date mentioned below as per the guidelines issued vide PBC No.76/2020 dated 18-05-2020.
