The above promotion is ordered subject to the following conditions:-

1. The promotions are ordered subject to the conditions that there are no prime-facie cases pending against him as a result of fact finding enquiry or otherwise and he is not placed under suspension or no departmental proceeding has been initiated/contemplated against him or there are no proposals to initiate proceedings at a later date or he is not undergoing any penalty debarring them from promotion.
2. The promotion ordered will take effect only from the date of shouldering higher responsibility.
3. They will be on probation for 12 months in the promotion grade.
4. They are eligible for all privileges on transfer account.
5. The date of relief/joining should be advised to all concerned.
6. The pay of the employee on promotion of CLI shall be fixed separately.
7. Employee who are promoted on regular basis is allowed to exercise option for fixation of pay on promotion within one month from the date of this office order under Rule 1313 FR22(I)(a)(1) R.II.
8. The above promotion has been issued only after ascertaining quantifiable data of representation of SC and ST employees in the grade. Accordingly the promotion order is issued in compliance with the directions of the Hon'ble Supreme Court in M Nagaraj case.

9. In terms of RBE No:177/2016 (PBC No:139/2016), the above promotion is provisional and subject to the final outcome of the pending contempt petition Civil No:314/2016 in SLP No:4831/2012 before the Hon'ble Supreme Court of India and also to the final outcome of OA/180/1074/2016 before the Hon'ble Central Administrative Tribunal, Ernakulam and also the OA 180/455/2021 and its connected matters.
