The above promotions are ordered subject to the following conditions.

1. The promoted employee will be on probation for a period of 12 months in the promoted grade. At the end of the probation period, if the appointing authority considered that the work of the Railway servant during the One year probation period on promotion has not been satisfactory, or the same is needed to be watched for some more time, they may revert back to the post or grade from which they are promoted or extend the period of probation as the case may be,

as stipulated in para-113 of IREM-1.

2. The promotion is ordered with the overall consideration that they are not undergoing any punishment, debarring them from promotion / officiating arrangement. However if they are undergoing any punishment they will be deemed to allowed carry out the current duties till become free from punishment.

3. The promotion should be given effect to within 10 days from the date of receipt of orders. The employees' relief with in the period specified above should not be delayed on the score that he/She has preferred an appeal and which is pending for disposal. Under any circumstances the above changes should not be delayed in being given effect to. Any lapse without proper justification will be viewed seriously. The actual date of relief and reporting for duty should be advised to this office promptly. If the employees are not willing to be promoted within the specified period, the same will be treated as refusal of promotion and he/she will be debarred from promotion for 01 year from the date of issue of the order.

3. The employees promoted may exercise option as indicated below:-

a. Either his/her initial pay may be fixed in the higher post on the basis of rule 1313 R.II (FR 22 (I) (a) (i)) straight away without any further review on accrual of increment in the pay scale of the lower post.

b. His or their pay on promotion may be fixed initially at the stage on a time scale of the new post above the pay in the lower post, which may be refixed on the basis of the provision of the rule 1313 (FR-22(I) (a) (i)) on the date of accrual of next increment in the scale of the lower post.

4. The above promotion will take effect only from the date him /her assuming higher responsibility.

5. The date of relief/ date of assuming higher responsibility may be advised to all concerned in time.

6. The above promotions are ordered subject to the outcome of the various cases pending in Courts. In terms of RBE 117/2016, the promotion is ordered purely provisional subject to the outcome of the pending contempt petition Civil No. 314/2016 and SLP Civil No. 4813/2012.

7. Railway quarters occupied if any at their present stations, should be vacated immediately on their relief unless they seek permission for retention of the same from this office. Failure to comply will be treated as an authorized occupation and damage rent will be recovered from their salary.

8. The employees promoted should undergo the mandatory MSTC training as and when arranged and her continuance in the promoted grade will be subject to successful completion of training.

9. The increment /confirmation as Jr.Clerk/future promotion of the above employees have to be regulated in terms of PBC 99/2017 dated 17.07.2017 dealing with passing of the prescribed typing skill test.
