The promotion is ordered on the condition that there are no prima facie cases pending against them as a result of fact finding enquiry or otherwise and that they have not been placed under suspension or no departmental proceedings have been initiated against them or there are no proposal to initiate proceedings at an early date or they are not undergoing any penalty debarring them from promotion.
- 4 The promotion ordered is purely provisional and subject to outcome of the pending Contempt Petition Civil No: 314/2016 and SLP Civil No:4813/2012.
5. The promotion ordered is purely provisional subject to the outcome of the cases pending in various courts on SC/ST reservation.
6. " Any excess payment found to have been made in regard to this order is required to be refunded ,when detected later by Railway.
