Sub: Selection for the post of Stenographer/Gr.III in Pay Matrix Level-4(.Grade Pay Rs 2400) - PGT Division (by adding 25% promotion by selection from Shorthand knowing' clerks' & 25% promotion by General selection from Group 'C' employees knowing shorthand)

1. It is proposed to conduct a General selection by calling volunteers from Group 'C' regular employees knowing shorthand with Pay Matrix Level-1 to Level-4 (Grade pay between Rs 1800/- to Rs 2400 / -) against 50% quota (25 % +25 %) for the post of Stenographer Gr.III in Pay Matrix Level-4 (.Grade Pay Rs 2400).

3 vacancies (01-SC, & 02-UR)

(i) 25 % by promotion by selection from Shorthand knowing Clerks /Typist in Level-2 for 1 vacancy (1 UR).

(ii) 25 % by General Selection from serving Group "C "employees knowing shorthand in Level 1 to 4 for 2 vacancies (1 SC & 1UR)

2. The selection will consist of the following tests:-

a) Written Test: Written Test consists of a test in English Grammar (Composite paper for testing the language (English) along with General awareness). As per RBE No 196/2018 the question paper will be 100% objective type multiple choice questions for the written examination and 10% of the total marks will be from official language policy and rules in terms of Board's letter No Hindi-81/OL-14/12 dated 14.01.1982.

There shall be negative marking for incorrect answers. One third of the marks allotted for each question will be deducted for wrong answers. Cutting ,over writing erasing or alteration of any type will not be evaluated. Zero marks will be given for answer having correction/overwriting. The time for the Examination will be 2 hours (100 marks).

b) Shorthand: Speed test of 80 words per minute for 10 minutes duration with Transcription time of 50 minutes.

c) Viva-Voce. Viva-voce is to be conducted in terms of RBE No 154/2005 issued under PBC No 144/2005 dated 12.09.2005 for those who have qualified in written examination and speed test.

3. (a) Regular Office Clerk /Typist working in Pay Matrix Level -2 (GP Rs.1900/-) who have completed 2 years minimum service (as on the date of notification) and acquired knowledge of shorthand are eligible to appear for the above selection against Para 1 (i) above.

(b) All Group "C " regular employees in Pay Matrix Level-1,2,3,&4 (i.e,GP.Rs.1800/- to Rs 2400/-) who have completed 2 years minimum service (as on the date of notification) and acquired knowledge of shorthand are eligible to appear for the above selection against Para1 (ii) above.

4. The volunteers should submit their application in the prescribed Proforma A to Personnel Branch and they are also required to submit attested copies of certificates in support of their educational qualification & Community Certificates (for SC/ST) along with the application.

5. In case of their selection, they will not be allowed to go back to their parent cadre and will have avenue of promotion only in the Stenographers cadre.

6. Candidates selected for the post of Stenographer Gr.III in Pay Matrix Level-4- (Grade Pay Rs. 2400/-) **must be prepared to go on line and accompany officers.** If they are not willing to go on line etc. they need not apply.

7. Those employees who agree to these conditions may apply in the proforma enclosed, duly getting their applications forwarded by their respective Supervisors on or before 02.11.2021 i.e the date it is to be received at Divisional Office. All Supervisors are therefore advised to ensure that the applications will reach Divisional office before 17.45 hrs of **02.11.2021**. **Any applications received after the time & date specified will be rejected** even though the employees would have submitted their applications to the respective Supervisors on or before the date specified. Late receipt of applications on the plea that staff were on leave, sick list, out of Headquarters etc. will also not be entertained. For this purpose, the Controlling Officers are specifically requested to take appropriate action in their respective offices.

8. The candidate selected for the post must be fit in **Cee-One medical classification.**

9. Wide publicity may be given to all staff under your control. Applications received beyond target date should not be entertained and the same should be disposed of by the Controlling Officers, rejecting them on account of late receipt.

10. In case no applications are received in your office/unit, a NIL report may be sent on or before **02.11.2021**.

Applications from SC/ST employees should necessarily have the caste certificates issued by the Competent Authority i.e Tahsildar for 'SC' Community and RDO for 'ST' community.

There will be no supplementary examination.

The Controlling Officers should acknowledge receipt of this notification.
