4. He is eligible to exercise option for fixation as mentioned below.

(a) to get their pay fixed in the grade pay either from the date of their up gradation.

OR

(b) From the date of their next increment . The pay and the date of increment would be fixed in accordance with clarification no.2 Railway Board's letter No.PC-VI/2008/1/RSRP/1 Dtd.25.09.2008 (PC-VI/22 RBE No.132/2008).

5. He is also entitled to avail Advances, Loans, Passes and PTOs, TA & higher type of accommodation based on the pay fixed on financial up gradation.

The above fixation is subject to verification and in the light of audit observation, excess payment made, if any, either in the form of arrears or otherwise shall be recovered either by adjustment against future payment due to the employee without any future notice.
