

**NOTIFICATION**

**Sub: Engagement of Ex-Servicemen on contract basis as  
Gatemen in interlocked level crossing gates in  
Operating Dept of Palakkad Division.**

Applications are invited from eligible Ex -servicemen for engagement on contract basis to work as Gate-men in interlocked level crossing gates in Operating Dept of PGT Division for engagement as contract Points Man B . Applications in the prescribed format (Annexure-A) may be submitted from interested Ex-Servicemen for engagement as Contract Pointsman-B in the interlocked level crossing gates in Operating Department of Palakkad Division, Southern Railway who fullfill all the following eligibility conditions.

1. Google form can be accessed via / <https://forms.gle/J1tSUp6v142VJQgL6> verification will be conducted in Person. Posts are temporarily only.

**1 Eligibility conditions as on the date of notification:**

- a) Ex- Servicemen who have retired after putting 15 years of service and passed Army Class-I certificate or equivalent and possess Discharge certificate, Ex-Serviceman identity card and Pension Payment Order will be considered eligible for engaging on Contact basis.
- b) Retired personnel from Para Military forces, viz., **BSF, CRPF, CISF, etc, are not eligible to apply.**

**2 Age: Should not have completed 50 years of age as on 17/01/2022**

**NB.** Personnel still serving in the armed forces as on date of issuing of notification will not be considered. Only those discharged from service on or before the date of this notification alone will be considered for engaging contract basis.

**3 Educational qualification:** Minimum educational qualification is X Standard Pass -(SSLC/Equivalent Army Education).

**4 MEDICAL CLASSIFICATION:-** Aye two under relaxed standard of Ex-Servicemen.

**5. PROCEDURE FOR RECRUITMNEEN OF EX- SERVICEMEN**

Application received from the Exservice men through Google form on 24/01/2022 . Shortlisted Ex servicemen will be called for verification of Original documents.

The Candidate shall attend the document verification, along with all relevant original certificates, at the date, time & venue specified by this office.

Any request for change of date, time and venue of Document verification will not be entertained.

Those Ex servicemen successful in Document verification will be subjected for medical Examination to be engaged on contract basis will be based on the length of Military Service after successful Document verification to the extend of notified posts.

**6. Training:**

The Ex servicemen selected for engagement will be imparted necessary training wherever applicable for a period which will be determined by the Administration before their actual deployment.

**7. MONTHLY REMUNERATION**

Engagement will be on full time contract basis and the remuneration will be on monthly basis comprising of Basic Pay, DA, TA,HRA & Dress allowance of Rs. 5000/- per annum wherever applicable.

**8. Place of posting:**

Ex-Servicemen who are found suitable will be engaged as Gatemen in interlocked gates on contract basis and posted over the jurisdiction of Palakkad Division.

**9. Conditions of engagement:**

a) After the scrutiny of the applications, medical examination and imparting of training is completed, the Ex-Servicemen will be subjected to a screening process to assess their suitability for engagement. After the screening, the recommended candidates shall execute an agreement in a non judicial stamp paper to the value of Rs.100/- in the required format before their actual deployment for working.

**10. General conditions**

- i. The contract of Ex-servicemen for Level-1 post for fulltime basis and shall not be entitled for Railway Quarters and Privilege/Complementary pass etc.
- ii. Duty pass may be provided for stretch of the journey involved on duty. They may be entitled to IInd class Duty pass.
- iii. The contractual staff may be permitted weekly off and National holidays. However, they may be called for duty on any day including National Holidays for which compensatory rest may be given later.



- iv. These contract engagement staff clear vacancies of Direct Recruitment Quota for maximum period of one year or availability of a regularly selected candidate whichever is earlier. Suitable break may be given between successive contracts. (if any)
- v. The contract may be terminated by either side by giving 15 days notice/. The performance monitoring of contracting appointment will be done on regular basis and those who are unable to discharge the duties of who fail to perform as per expectations of the administration, may given 15 days notice and their contract shall be terminated. However, when contract staff found to have mentally/physically incapacitated and in case of gross negligence/misconduct/misbehaviour/irregularities, the engagement contract may be terminated with immediate effect.
- vi. The engagement of contract basis will not confer any right to claim for regular absorption/extension in the Railways.
- vii. They may be paid daily allowance when on tour is admissible, at the rate Rs.500/-
- viii. In the case of absence for duty proportionate amount of the pay for the day will be deducted. If fulltime contract Ex-servicemen are on unauthorised absence beyond 3 days their engagement will automatically will terminate.
- ix. The SC/ST/OBC candidates should submit a self attested copy of community certificate issued by the competent authority.
- ix It is brought to the notice of the applicants that this engagement on contract basis will not confer them any right to claim for absorption or for permanent posting in Railways.

**11.** Ex-Servicemen who are found suitable will be engaged as Gatemen in interlocked gates on contract basis over the jurisdiction of operating Dept of Palakkad Division. Only those who are willing for posting in any LC gates of operating dept situated in the jurisdiction Palakkad Division need to apply. Jurisdictions of PGT division are Stations coming **between PGT- MAQ-MAJN PADIL - JOKT -PNMB, PGT-PGTN-POY-CNV, SRR-NIL PGT-MDKI**. The screening committee mentioned above will also determine the place of posting. No request for change place will be entertained after posting

**12. Certificates and documents to be submitted:** Fill in application form (Annexure A) and Self attested copies of 1)Aadhaar card, 2)Ex-Servicemen Identity card, 3)Discharge Certificate, 4)Pension Payment Order and 5)Educational qualification certificate (only Matric/X Standard/SSLC or equivalent certificate).

**13 .**Working hours will be 12 hours per day or 8 hours per day depending upon the Gates they are posted.

**14** Ex-Servicemen must wear uniform and other gear prescribed by the Railways

**15** Ex-Serviceman who wish to be deployed as Gateman on contract basis on accepting all the terms and conditions laid above and agreeing to perform the Gatemen duties are advised to submit their applications through on line mode.(Google Form) on or before 24/01/2022.They should produce the

enclosed format in Annexure "A" duly filled, while reporting this office for Screening.
