Sub: Selection for the post of Station Master in Pay Matrix Level-6 of VII PC against 25% General Selection - Reg.

Ref: Railway Board letter No. E(NG)1-2016/PM1/12 dt. 16.02.2018 & Advanced Correction Slip No. 241 of IREM Vol.I (RBE No.22/2018)

It is proposed to conduct a selection for the post of Station Master in Pay Matrix Level-6 of VII PC against 25% General Selection. Applications are invited from volunteers from amongst the employees of Operating Department subject to the following conditions.

I) VACANCIES ASSESSED

The number of vacancies assessed is indicated below.

II) CATEGORIES ELIGIBLE TO APPLY FOR THE SELECTION

Employees of Operating Department in the following categories.

- Shunting Master Gr II, & Sr.Train Clerk in Level-4
- Pointsman 'A' & Train Clerk in Level-2
- Pointsman 'B' in Level-1

III) ELIGIBILITY CRITERIA

- Upper Age Limit (as on 23.03.2022) : 45 years (50 years in case of SC/ST)
- Qualification : Matriculation
- Minimum service rendered :
Employees in Level-1 : 5 years regular service

Employees in Level-2 : (a) PM 'A' & TNC promoted from Level-1 are eligible
(b) TNC appointed against DRQ with 2 years regular service are eligible

Employees in Level-4 : Shunting Master Gr II & Sr.Train Clerk are eligible

IV) SELECTION CRITERIA

The selection consists of written examination and scrutiny of record of service / Performance report. In terms RBE No. 196/2018 (PBC No. 263/2018 dt. 21.12.2018), the question paper will contain 100% Objective type questions. There will be negative marking for a wrong answer. One third of marks allotted for each question will be deducted for wrong answers. The employees who secure 60% in the written examination will be directed for medical examination for fitness in 'Aye Two' classification and for an Aptitude Test and such of those employees certified fit in 'Aye Two' classification and suitable in Aptitude test will only be considered for empanelment to the extent of vacancies. Being a safety category, no relaxation of marks will be allowed in respect of SC/ST employees. The panel will be formed in the order of merit based on the aggregate marks of professional ability, record of

service and Aptitude Test. There will be no classification of 'Outstanding' as per RBE No. 113/2009 dt. 19.06.2009.

10% of the total marks will be from Official Language policy and rules. The questions on Official Language policy and rules may not however be compulsory.

In terms of Railway Board letter No. 88-E(SCT)I/42/2 dt. 11.04.1991 (RBE 71/1991), pre-promotional training to SC/ST employees for a period of 3 to 4 weeks will be conducted covering the syllabus of the examination for the above selection. In case if any employee expresses his unwillingness for pre-selection training, a written declaration to that effect may be forwarded to this office.

Further, all the employees empanelled will be directed to undergo induction training at MDZTI/TPJ and only on successful completion of training they will be absorbed against working post of Station Master in Pay Matrix Level-6 of VII PC. During the period of training, they will draw either stipend or existing pay as per their option.

Employees who are promoted as Station Masters in Pay Matrix Level-6 of VII PC after successful completion of training at MDZTI/TPJ should seek their further promotions in SM cadre only and they will not have any claim in future for seniority, promotion etc in their erstwhile cadre.

The syllabus for the written examination is enclosed. Since the selection is by calling volunteers, there will be no supplementary examination for the absentees in the main examination.

Wide publicity shall be given to this notification. The Supervisors concerned are personally responsible to ensure that the selection is notified to all eligible employees working under their control and relieve them to attend the written examination. The employees who are on Leave / Sick / Duty at outstations or relieved to other stations on transfer etc are also to be advised by the respective Supervisors.

Applications in the prescribed proforma duly forwarded with date shall be sent in one bunch with covering letter addressed to Sr. Divisional Personnel Officer/PGT so as to reach this office **on or before 13.04.2022**. Application without date will not be entertained. Application received after the due date and applications received directly without being forwarded by supervisory officials will not be entertained.

Those who have submitted their applications will be alerted to appear for written examination subject to eligibility for which separate notification will be issued.
