1). **The promotion will take effect from the date they assume higher responsibilities.**

2). वे निलंबनाधीन नहीं है और उनके विरुद्ध कोई अनु अ नि, विपुस्था, सतर्कता का मामला लंबित/अवेधित नहीं है और वे ऐसी कोई सजा नहीं भोग रहे है जो उन्हें पदोन्नति से रोकें । पदोन्नति प्रभावी करने से पहले पर्यवेक्षी अधिकारियों को ये सुनिश्चित करना चाहिए । They are not under suspension, no DAR/SPE/Vig. cases are pending/contemplated against them and they are not undergoing any punishment debarring them from promotion supervisors should and the same before the promotion are given effect to.

3). ऊपर पदोन्नत कर्मचारी इस आदेश की प्राप्ति की तारीख से 15 दिनों को भीतर पदोन्नति कार्यान्वित करेंगे ,चूकने पर इसे पदोन्नति से इनकार माना जाएगा और परिणामस्वरूप एक साल की विवर्जन अवधि की समाप्ति से पूर्व उन्हें पदोन्नति के लिए विचार नहीं किया जाएगा और इस बीच पदोन्नत सभी कनिष्ठों से वे अपनी वरिष्ठता खो बैठेंगे ।

बैठेंगे। The employees promoted above shall carry out their promotion within 15 days, from the
receipt of this order and failure to do this will be treated as refusal of promotion and consequently
they will not be eligible to be considered for promotion before the expiry of one year debarment
period and they will lose seniority to all their juniors promoted in the mean while.

4). पदोन्नत ग्रेड में 12 महीने की परीचीक्षा अवधि है। परीचीक्षा अवधि के अंत में यदि नियोजक अधिकारी
को लगे कि उक्त अवधि के दौरान रेल कर्मी का कार्य निष्पादन संतोषजनक नहीं है या उनका निष्पादन कुछ समय
और परखना है तो भारस्थानि-1 के पैरा 113 में अनुबंधितानुसार वे कर्मचारी के पुराने पद को प्रत्यावर्तित कर
सकते है या परीचीक्षा की अवधि बढ़ा सकते हैं जो भी मामला हो।

There is a probation period of 12 months in the promoted grade. At the end of the
probation period, if the appointing authority considers that the work of the Railway servant during
the one year probation period on probation has not been found satisfactory or the same is needed
to be watched some more time, he may revert the concerned employee, to the post from which
the employee was promoted or extended the period of probation as the case may be, as stipulated
in Para 113 of IREM-1.

5). The Promotees are allowed to exercise option under Rule 1313(FR-22)(I) (a) (i) of R.II
within a period of one month from the date of issue of this order. In case he do not exercise any
option within the stipulated period, pay will be fixed as envisaged under Rule 1313 (FR-22) of R.II
and no further option/ revision is permissible.

6). The employees who are receipt of Financial up gradation under MACP Scheme-2008 in the
promoted pay band & Grade pay are not entitled for further fixation pay on promotion.

7). The above promotion shall be subject to further orders which may be passed by the
Hon'ble Supreme Court.
