- The financial up gradation under MACP is granted subject to the following conditions:
- They are free from DAR/SPE/VIG/RPUP cases and not undergoing any effective penalty.
 - The above MACP in the higher grade Pay is granted in accordance with the hierarchy of the recommended revised pay bands and grade pay as given in Section I, part A of the first schedule of the Railway services (Revised Pay) Rules 2008. They are eligible to draw higher pay from the date mentioned above.
 - There will not be any change in the Designation and nature of the duties to be performed. The MACP benefit under this scheme is only on personal basis and it shall not have any relevance to their seniority position. The present post of the employee remains unchanged.
 - It will not confer them any seniority benefits. Their name will be continued to be maintained in the original seniority list and they will be considered for promotion on

- regular basis in the normal channel only.
- In case where financial upgradation under ACP/MACP scheme has already been granted and pay fixed accordingly, no further pay fixation will be granted at the time of regular promotion, if the promotion is in the higher GP/Level only the difference of GP/Level would be admissible at the time of regular promotion.
- The pay is fixed in accordance with the Rly Bd's letter No PC-VI/2008/1RSRP/11 dt 25.09.08 (RBE No 132/08). They may exercise option for fixation of pay if the same is advantageous to them.
- They are also entitled to avail pass, Advances, Loan, TA and higher type accommodation based on the pay fixed on financial upgradation.
- They are eligible for annual increment on 01.07.19.

In terms of PBC No. 184/2017 any wrongful promotion/Excess payment on grant of MACPs detected subsequently will be subject to rectification and recovery.

The following employees are not considered for grant of financial upgradation under MACP since they are not having the required APAR grading in terms of Railway Board's letter No. PC-VI/2008/ACP/2 Dt. 19.12.2016 (RBE. No. 155/2016 dt. 19.12.16.)
