3. It will not confer on them any seniority benefits, their name will be continued to be maintained in the original seniority list and they will be considered for promotion on regular basis in the normal channel only.
4. There shall be no change in the designation, classification, or higher status.
5. They may exercise option for fixation of pay if the same is advantageous to them.
6. In case where financial upgradation under ACP/MACP Scheme has already been granted and pay fixed accordingly, no further pay fixation will arise at the time of regular promotion, if the promotion is in the higher GP/Level only the difference of GP/Level would be admissible at the time of regular promotion.
