The above upgradation is subject to the following terms and conditions :-

1. There are no DAR/SPE/Vig cases and not undergoing any effective penalty.
2. There will not be any change in the Designation and nature of the duties to be performed. The MACP benefit under this scheme is only on personal basis and it shall not have any relevance to their seniority position. The station of the employee remain unchanged.
3. In terms of PBC No.184/2017 any wrongful excess payment on grant of MACPs detected subsequently will be subject to rectification and recovery.
4. Based on the recommendations of 7th CPC , the benchmark for grant of MACPs has been enhanced from "GOOD" to "Very Good" w.e.f.,25.07.2016.
5. In terms of RBE No.26/2020 dt:25.02.2020 the promotion from the post of ASM (G.P.2800) to SM (GP 4200) need not be reckoned for the purpose of MACPs. As the amendment in the recruitment provisions for the Station Masters has been notified vide Board's letter dt:16.02.2018, the benefit of MACPs ignoring the promotion from ASM to SM shall be admissible w.e.f. 16.02.2018 and In terms of Rly.Bd's letter dt: 24.11.2020 and PCPO/MAS Ir.Dt 08.02.2021, have reviewed the eligibility for MACP of the SM category duly ignoring the promotion from ASM to SM be made admissible from 16.02.2018 irrespective of their progression in other cadres.
