<p>Selection/Suitability and other conditions for re-engagement</p>	<p>a) Suitability /Competency of the retired employee will be adjudged before the re- engagement and the issue of their safety records as well as the safety and other operational requirements as needed, will be adequately scrutinized. The selection is subject to the retired employees being found suitable by the committee constituted for the purpose.</p> <p>b) Re-engaged retired employee will be discharged immediately, on joining of the selected candidate from RRB/RRC or regular employee on transfer/promotion.</p> <p>c) The Administration is at liberty to terminate the service of the re-engaged personnel after giving a notice period of one month, in case they are performance is found to be unsatisfactory. The service of the re-engaged personnel will be terminated on attaining the age of 65 years or on of joining the selected candidate from RRB/RRC or posting of regular employees on transfer/promotion or on whichever is earlier. The re-engaged employees will not have the right for continuity in service.</p>
