

The following additions may be incorporated in this notification dated: 06.04.2023, cited under ref (4).

1. After Para (2) - in terms of RBE: 62/2017 dated: 28.06.2017 in Para (5) Definition of Disabilities (i) (a) Blindness: "Blindness" refers to a condition where a person suffers from any of the following conditions, namely :- (i) total absence of sight; or (ii) visual acuity not exceeding 6/60 or 20/200 (snellen) in the better eye with correcting lenses; or (iii) limitation of the field of vision subtending an angle of 20 degree or worse, (b) **Low vision:** " Person with low vision" means a person with impairment of visual functioning even after treatment or standard refractive correction but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

2. After Para (4) b - In terms of Para 16 (a) of RBE: 62/2017 dated: 28.06.2017 further age relaxation of 10 years in upper age limit shall be allowed to PwBDs subject to the condition that maximum age shall not exceed 56 years.

3. In Para 5 (d) the last date for submission of applications shall be read as "**29/05/2023**" instead of **08.05.2023**.

4. After Para (9) - For Medical examination of PwBDs the instructions contained in Para 19 of RBE No: 62/2017 will apply.
